

## **Barrel Race**

- Anyone who enters and competes at 3 or more races will be eligible for awards at our series finals and any sidepots throughout the series (must have run at 3 events in the series PRIOR to the day of the sidepot). \*<u>If at</u> the end of a series production there are not enough members FSR reserves the right to either not award prizes/cash OR to award prizes/cash giving preference to the racer who has competed in the most events and then points earned. For example: Anndee entered 3 races and has 5 points and Carol entered 2 races with 5 points so 1st goes to Anndee as an actual member and 2nd goes to Carol as a non-member. Further more, if Anndee has entered 3 races and has 5 points and Carol has entered 2 races and has 7 points Anndee still takes 1st as a member where Carol will receive 2nd as a non-member\*
- Classes will run as follows:
  - Boss Lady Open class will be run as a 4D; unless there are over 150 entries then it will be run as a 5D. See chart below for division splits.

- Novice Horse will be run as a 2D; see chart below for division splits. Horse must have less than \$1000 LTE at the start of the series. Any complaints or disputes on a horse's novice status must be accompanied by written proof of LTE provided by the person filing the complaint/dispute. If producer finds complaint/ dispute to be valid the horse will be moved from the Novice Horse class, and will be allowed to keep points prior to the discovery.
- Youth is 17 and under at the start of the series and will be run as a 4D; see chart below for division splits.
- Novice Youth will run as a 2D; see chart below for division splits.
   14 and younger at the start of the series. If entered in Novice Youth a rider may not enter in any other class. A rider may compete at the Novice Youth level until they place in Youth or Open times two times during a series after that they will be required to run in Youth or Open going into the NEXT YEAR that series and in following series.
- PeeWee will run a bit differently as we expect this to be an actual PeeWee class and riders in this class may not enter in any other class. 12 year old and younger at the start of the series. If a rider in the PeeWee ever runs a time that would place them in the 1D of Novice Youth they will be required to run in that class going forward. They will be allowed to keep points up to that race in the PeeWee, but going forward can only run in the

Novice Youth or higher classes. PeeWee will have 2D format with the 1D being riders that do not use a lead line and the 2D being riders that are on a lead line. This class pays out 100% of entry fees.

- Anyone who enters and competes at 3 or more races will be eligible for awards at our year end finals and any sidepots throughout the series (must have run at 3 events in the series PRIOR to the day of the sidepot).
- In order to keep confusion on entries to a minimum we require that you
  use your REGISTERED horse name. Failure to do so will result in a
  warning the first time and then any additional failures to use the registered
  name will result in a DQ for that race and no refund of any fees paid.
- We are keeping track of horses so you MUST run the horse listed in the draw it is listed at. First offense is an automatic DQ and no refund of any fees paid at that event on each horse not run at its assigned draw. (So if Horse A is draw 12 and Horse B is draw 24 and you run Horse B at the 12 spot you will be disqualified for both runs.) Second offense you will be DQ for the remainder of the series and no refund of any fees paid, you will lose your points, and will not qualify for any awards in that year's series. In order to prove that someone is running the wrong horse there must be video with sound showing that the announcer is calling the horse name

and it being the wrong horse OR it must be announced by the witness AT THE END OF THAT RIDER'S RUN. No complaints will be considered valid without one of those two conditions met.

- Each horse may only be run once in each class, no running the same horse twice in the Open or Youth. The only exception is in the PeeWee and Novice Youth as we understand that some families only have one horse that the children share so the same horse may be run with a different child riding.
- Any disputes must be presented within 24 hours from the time the results are posted on the site to dispute the standings. If dispute is not filed within that time the results will stand as posted.
- Each qualifier may win multiple awards based points in each class and in each D within a class.
- You may roll your time from Youth to Novice Horse or from Youth or Novice horse to the OPEN. Roll times must be within same day (no rolling from day to day unless otherwise noted). Rolls must be specified at time of entry or you will run in each class separately.
- Entries close when announced or posted. Listen for entry closure times at the event.
- Exhibitions available on a first come first serve basis. They are \$5 each for non-timed and \$10 for timed. Rider is responsible to run their exhibitions before the time closes. No refunds on unused exhibitions.

- Draw out and Turn out fee refunds are at the producers discretion and will be decided on a case by case basis.
- Fees are as follows, unless posted otherwise (See specific event flyers for exceptions):

o Peewee \$10, 100% to payout and is split between the 2 divisions based on the entries in each division. Office fee for PeeWee is \$5.

o Novice Youth \$30 o Youth \$40 o Novice Horse \$40 o Open \$50 o Office fee \$10 per person per event

Youth events can be ROLLED to the YOUNG GUNS youth rodeo summer series.

## Points will be awarded in the following order:

- 1<sup>st</sup> 5 pts
- 2<sup>nd</sup> 4pts
- 3<sup>rd</sup>- 3 pts
- 4<sup>th</sup>- 2pts
- 5<sup>th</sup>- 1 pt

Places paid at individual events and Series awards will be presented based on the average number of competitors in each event for the series.

Example of series end Award depth: Novice youth per event has 10 entries, 8 entries, 13 entries, 9 entries, 15 entries this gives a total of divided by 5 events is 11 so the awards would be given to a minimum of 1 place in each D. We will award up to 5 places in each D based on Places Paid or Award Placed chart.

## **Facility Standards:**

• Only the next 10 runners in the main holding area and only the next 20 after that. If you are in either area before your number is to be there it is grounds for disqualification and no refund of entry or office fees will be given.

- No tie outs no portable pens in parking lots.
- CASH ONLY payment and CASH PAYOUT unless you need payment mailed then it will be a check.
- Pick up all trash, manure, and shavings before leaving Riata. If your horse digs a hole please scoop the dirt back in to repair it.
- Full Send Rodeo Productions a dba of Riata Ranch Event Center LLC reserves the right to deny entry at its discretion and reserves the right to evict any person at any time. There will be no refund of fees if you are evicted for violence, vulgarity, cheating, attempting to cheat, or using performance enhancing drugs (exemption for things like Lasix or other veterinary prescribed allowable drugs).
- Sportsmanship:
  - Poor sportsmanship will NOT be tolerated. No mistreatment of any personnel involved with series production; including but not limited to office staff, arena staff, grounds crew, sponsors. It also includes any mistreatment to competitors and other contestants no bullying or harassing. Person filing the complaint will need either video or documentable proof (ie text message or facebook comments) OR an unbiased witness such as a judge at the event.

First offense is a warning. Second is DQ from the day's event with no refund. Third is banning from the remainder of the series.

- No animal abuse will be tolerated. This is your warning we have a zero tolerance policy and will DQ all entries at the time of the abuse with no refund of any fees. A second occurrence will result in banning from the series and contacting the local authorities.
- Destruction of property will result in DQ with no refund of any fees, banning from property, authorities will be contacted, and charges pressed.
- Full Send and Riata are hosting fun and professional events that our contestants, families, and event attendees can enjoy and be proud to be involved with as such professionalism and courtesy are key to our events.
- Should there be any outstanding balance owed to the Riata or Full Send Rodeo Productions those fees must be taken care of prior to being allowed to enter any events.
- Everyone winning a check must have a current W9 on file in order for Riata to release checks/winnings. NO EXCEPTIONS. Failure to submit a W9 at the competition will result in forfeiting of winnings. W9 forms are posed on the website for your convenience AND available at every event. If you choose to have a check mailed to you and you do not cash it within 3 months check will be void and you forfeit your winnings.

Every Person Must Read and Understand this Waiver Before Participating in Equine Activities.

The following waiver of all claims, release from all liability, assumption of all risks, agreement not to sue and other terms of this agreement are entered into by me (the Participant) with and for the benefit of Riata Ranch Event Center LLC, its directors, officers, employees, volunteers, business operators, agents and site property owners or lessees (collectively the "Host"). Without limiting the generality of all, "Equine Activities" includes but is not limited to team roping, barrel races, and other riding activities provided by/at the "Host" to the Participant.

**1.)** I am aware that there are inherent dangers, hazards and risks (collectively "Risks") associated with "Equine Activities" and injuries resulting from these "Risks" are a common occurrence. I am aware that the "Risks" of "Equine Activities" mean those dangerous conditions which are an integral part of "Equine Activities", including but not limited to:

(a) the propensity of any equine to behave in ways that may result in injury, harm or death to persons on or around them and to potentially collide with, bite or kick other animals, people or objects;

(b) the unpredictability of an equine's reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals and hazards such as subsurface objects;

(c) the potential for other participants to behave in a negligent manner that may contribute to injury to themselves or others, including failing to act within their abilities to maintain control over an equine.

**2.)** I freely accept and fully assume all responsibility for all "Risks" and possibilities of personal injury, death, property damage or loss resulting from my participation in "Equine Activities".

**3.)** I agree that although the "Host" has taken steps to reduce the "Risks" and increase the safety of the "Equine Activities", it is not possible for the "Host" to make the "Equine Activities" completely safe. I accept these "Risks" and agree to the terms of this waiver even if the "Host" is found to be negligent or in breach of any duty of care or any obligation to me in my participation in "Equine Activities".

**4.)** In addition to consideration given to the "Host" for my participation in "Equine Activities", I and my heirs, next of kin, executors, administrators and assigns (collectively my "Legal Representatives") agree to:

(a) waive all claims that I have or may have in the future against the "Host";

(b) release and forever discharge the "Host" from all liability for any personal injury, death, property damage, or loss resulting from my

participation in the equine activity due to any cause, including but not limited to negligence (failure to use such care as a reasonably prudent and careful person would use under similar circumstances), breach of any duty imposed by law, breach of contract or mistake or error in judgment of the "Host"; and

(c) to be liable for and to hold harmless and indemnify the "Host" from all actions, proceedings, claims, damages, costs demands, including court costs and costs on a solicitor and own client basis, and liabilities of whatsoever nature

or kind arising out of or in any way connected with my participation in "Equine Activities".

5.) I agree that this waiver and all terms contained herein are governed exclusively and in all respects by the laws of Wyoming where the "Equine Activities" are engaged at the "Host". I hereby irrevocably submit to the exclusive jurisdiction of the courts of Laramie County, Cheyenne, Wyoming and I agree that no other court can exercise jurisdiction over the terms and claims referred to herein. Any litigation to enforce this waiver will be instituted in the Laramie County, Cheyenne Wyoming in which the "Equine Activities" are provided by/at the "Host".

6.) I confirm that I have had sufficient time to read and understand this waiver in its entirety. I understand that this agreement represents the entire agreement between myself and the "Host", and it is binding on myself and my "Legal Representatives".

**7.)** I confirm that I have reached the age of majority in the province in which I am participating in "Equine Activities". If under age please have your parent/ guardian contact us to sign release.

8.) Photo/Video release I understand that photos and videos may be taken of me and my animals at Riata Event Center and used for marketing and that there will be no compensation/consideration. I release my right to inspect or approve finished product. Riata Event Center LLC and staff are held harmless and release and forever discharged from all claims/cause of action from me, my heirs, or any other person acting on my behalf or my states behalf.
